Smoking Ban Policy at Northern Technical University (NTU)

Northern Technical University (NTU) is dedicated to fostering a healthy and safe environment for its students, employees, and visitors. To enhance public health and promote well-being, smoking is strictly prohibited in all university facilities, with designated smoking areas provided for those who choose to smoke. These areas will be clearly marked and equipped with ventilation and air purification systems to minimize the impact on nonsmokers.

Policy Objectives:

Scope of Application:

Procedures:

1. Prohibited Areas:

➤ Limited exceptions may be made for scientific research purposes, contingent upon prior approval from the university administration, ensuring strict oversight to maintain health and safety standards.
